ARTICLE 1: To elect a clerk and treasurer. There were no nominations tabled at this time.

ARTICLE 2: To elect the remaining officer, namely a trustee to serve a term of five years, an auditor to serve the term two years, an auditor to serve a term of three years and a delinquent tax collector for one year.

Trustee 5 years Lisa Arnold nominated Herbie Durham, second by Terry Tatro, no other nominations, nominations closed motion carried. Herbie Durham elected Trustee.

Auditor 2 years Lisa Arnold nominated Kayla Patnode second by Terry Tatro, no other nominations, nominations closed motion carried. Kayla Patnode elected Auditor.

Auditor 3 years Herbie Durham nominated Lisa Arnold second by Heath Bovat , no other nominations, nominations closed motion carried. Lisa Arnold elected Auditor.

Delinquent Tax collector 1 year Herbie Durham nominated Terry Tatro second by Travis Arnold, no other nominations, nominations closed motion carried.

ARTICLE 3: To receive and act upon the reports of the various Village officers. Herbie Durham motioned to accept Article 3, second Travis Arnold motion carried.

ARTICLE 4: To see if the voters of the Village of Alburgh will vote to raise the sum of \$23,299.86 by taxation, to be used for general village purposes to include street lights. Lisa Arnold motioned to accept Article 4 seconded by Herbie Durham motion carried.

ARTICLE 5: To see if the voters of the Village of Alburgh will vote to authorize the trustees to borrow money in anticipation of taxes to pay current expenses of the Village of Alburgh. Lisa Arnold motioned to accept Article 5, second by Herbie Durham, motion carried.

ARTICLE 6: To see if the voters of the Village of Alburgh will vote to pay taxes to the Village Treasurer heretofore. Herbie Durham motioned to accept Article 6 second Travis Arnold motion carried.

ARTICLE 7: To see if the voters of the Village of Alburgh will vote to donate the sum of \$700.00 towards the support of the Alburgh Public Library. Herbie Durham motioned to accept Article 7 second Travis Arnold motion carried.

ARTICLE 8: To transact any other business that may properly come before the meeting.
