**ARTICLE 1: Charter Amendment, Village Clerk**

Shall the Charter of the Village of Alburgh, as amended, be further amended to change the Village Clerk position from an elected position to an appointed position with no residency required by the Board of Village Trustees. Effective May 1, 2023, Through the Amendment of the Village Charter Subchapter 3: §203-301. ELECTION OF OFFICERS


Effective May 1, 2023, at each annual meeting of said Village of Alburgh there shall be elected the following Officers: One Trustee, ~~A Clerk~~ effective May 1, 2023 the Clerk will be an appointed position with no residency requirement, appointed by the Board of Village Trustees., A Collector, and one Auditor, such elections shall be by ballot if called for. Terms of Officers elected at the Annual meeting shall commence at the time of their election and continue for one year, and until their successors are chosen and qualified, except for the term of Office of Trustee whose term will be five years, and the term of office of Auditor whose term will be three years. ( AMENDED 2001,NO. M-10(ADJ. SESSION), § 2.)

**ARTICLE 2: Charter Amendment, Village Treasurer**

Shall the Charter of the Village of Alburgh, as amended, be further amended to change the Village Treasurer position from an elected position to an appointed position by the Board of Village Trustees. Effective May 1, 2023, Through the Amendment of the Village Charter Subchapter 3: §203-301. ELECTION OF OFFICERS

Effective May 1, 2023, at each annual meeting of said Village of Alburgh there shall be elected the following Officers: One Trustee, ~~A Treasurer~~ effective May 1, 2023 the Treasurer will be an appointed position with no residency requirement, appointed by the Board of Village Trustees., A Collector, and one Auditor, such elections shall be by ballot if called for. Terms of Officers elected at the Annual meeting shall commence at the time of their election and continue for one year, and until their successors are chosen and qualified, except for the term of Office of Trustee whose term will be five years, and the term of office of Auditor whose term will be three years. ( AMENDED 2001,NO. M-10(ADJ. SESSION), § 2.)


