Annual Meeting Minutes
May 5, 2026

Present: Herbie Durham, Heath Bovat, Aidan Poquette, Robert Savage, Walter Kane, Cheryl Dunn, Jason Beaulac. Visitors : Joanne Durham, Terry Tatro, Leonard James

Annual Meeting called to order at 7:30 by Chairperson, Herbie Durham

Article 1: To elect the remaining officers , namely a Trustee for five years, an Auditor to serve a term of 2 years, an Auditor to serve a term of 3 years, and a Delinquent tax collector to serve a term of 1 year.

Herbie Durham nominated Heath Bovat for trustee for a term of 5 years Heath Bovat declined the nomination, with no other nominations, no one was elected Trustee for 5 years. Terry Tatro nominated Mallory Ovitt Auditor to serve a term of 3 years, second Joanne Durham, being no other nominations, Mallory Ovitt was elected Auditor for 3 years, no other nominations for Auditor, leaving one open position for Auditor. Walter Kane nominated Cheryl Dunn Delinquent Tax Collector for 1 year, second Aidan Poquette, with no other nominations Cheryl Dunn was elected as Delinquent Tax Collector for 1 year.

Article 2: To receive and act upon the reports of the various Village Officers, a discussion following about errors made in the Annual Report after this discussion the Annual Report, will be corrected, suggesting that the reports get distributed before the meeting, the Trustees were in agreement that Village Reports will be hand delivered. Auditors and Trustees will look into the concerns brought forward. The Village Report was not accepted.

Article 3: To see if the Voters of the Village of Alburgh will vote to raise the sum of \$29,376.33 by taxation to be used for General Village Purposes, to include street lights, Terry Tatro motioned to accept, second Leonard James Article 3 accepted.

Article 4: To authorize the Village Trustees to borrow money in anticipation of taxes to pay current expenses of the Village of Alburgh, Terry Tatro motioned to accept Article 4, Joanne Durham second, Article 4 accepted.

Article 5: To see if the Voters of the Village of Alburgh will vote to pay taxes to the Village Treasurer heretofore. Walter Kane motioned to accept Article 5, second Robert Savage. Article 5 accepted.

Article 6: To see if the Voters of the Village of Alburgh will vote to donate the sum of \$700.00 towards the support of the Alburgh Public Library. Heath Bovat motioned to accept Article 6, second Aidan Poquette. Article 6 accepted.

Article 7: To transact any other business that may properly come before the meeting, Leonard James brought up the buildings in the Village that need to be cleaned up, Herbie Durham brought up the no zoning issue. Maybe some of these will fall under the Town Ordinances.

Terry Tatro motioned to adjourn at the meeting, Walter Kane second. Meeting adjourned at 8:13 PM
